It is FOUND that the Court has jurisdiction of the parties and the subject matter of this suit, and that the following orders are in the best interest of the child.

**PRIOR ORDER**

It is FOUND that on 1 / 20 / 2011 the Court ordered *AUBREY ROSHON TAYLOR* to pay current child support of \$350.00 monthly, beginning 1/1/2011 and monthly thereafter.

It is FOUND that on 1 / 20 / 2011 the Court ordered *AUBREY ROSHON TAYLOR* to pay current medical support of \$70.00 monthly, beginning 1/1/2011, and monthly thereafter.

**CHILD SUPPORT JUDGMENT**

It is FOUND and CONFIRMED that *AUBREY ROSHON TAYLOR* is in arrears on child support in the amount of \$ 18,257<sup>48</sup> as of January 31, 2015. This includes all unpaid child support and any balance owed on previously confirmed child support arrearages or retroactive support judgments as of the specified date.

A judgment is GRANTED against *AUBREY ROSHON TAYLOR* and in favor of the ATTORNEY GENERAL OF TEXAS in the amount of \$ 18,257<sup>48</sup>, with interest as provided by the law of:

- the State of Texas, at the rate of 6% per annum;
  - the State, \_\_\_\_\_, that issued the controlling order;
- for collection and distribution according to law.

*AUBREY ROSHON TAYLOR*, Obligor, is ORDERED to pay said child support judgment by paying \$ 1000<sup>00</sup> on or before the 13<sup>th</sup> day of February, 2015, and by paying \$ 500<sup>00</sup> each month beginning the 1 day of March, 2015, payable on or before that date and on or before the same day of each month thereafter until the arrearage is paid in full, or on the termination of current support for any child the subject of this suit.

If *AUBREY ROSHON TAYLOR* has not paid the judgment in full by the date his current child support obligation ends, he is ORDERED to pay the remainder of said judgment by paying \$ 850<sup>00</sup> each month on or before the same day of each month until the arrearage is paid in full. The withholding order authorized herein shall include such payments, but nothing herein shall prohibit the use of other collection methods authorized by law. The court's order setting payments on a child support judgment or on a medical support judgment does not preclude or limit the use of any other means for enforcement of the judgment.

**MEDICAL SUPPORT JUDGMENT**

It is FOUND and CONFIRMED that *AUBREY ROSHON TAYLOR* failed to provide medical support as ordered.

It is further FOUND that *AUBREY ROSHON TAYLOR* is in arrears on medical support in the amount of \$ 3824<sup>80</sup> as of January 31, 2015. This includes all unpaid medical support and any balance owed on previously confirmed medical support arrearages or retroactive support judgment as of the specified date.

A judgment is GRANTED against *AUBREY ROSHON TAYLOR* and in favor of the ATTORNEY GENERAL OF TEXAS in the amount of \$ 3824<sup>80</sup>, with interest as provided by the law of:

the State of Texas, at the rate of 6% per annum;

The court's order setting payments on a child support judgment or on a medical support judgment does not preclude or limit the use of any other means for enforcement of the judgment.

**NOTICE TO OBLIGOR**

Any judgment(s) rendered herein is not an installment debt and the entire judgment is now due and owing. The ATTORNEY GENERAL OF TEXAS may take whatever enforcement remedies deemed necessary including any remedies required by federal or state laws to collect this judgment, even if regular periodic payments on this judgment are being made.

*AUBREY ROSHON TAYLOR* is placed on notice that should he fail to pay current child and medical support, or toward the arrearage as ordered herein, the ATTORNEY GENERAL OF TEXAS may pursue an action to suspend any or all licenses he may have.

Pursuant to Texas Family Code § 157.269, the Court retains jurisdiction over this matter until all current support and all support arrearages, including interest and any applicable fees and costs, have been paid.

**PAYMENT OF SUPPORT, ATTORNEY'S FEES AND COSTS**

**INCOME WITHHOLDING**

Pursuant to Texas Family Code Chapter 158, any employer of *AUBREY ROSHON TAYLOR*, current or subsequent, is ORDERED to withhold income from the disposable earnings of *AUBREY ROSHON TAYLOR* for the child's support as set out in the ORDER/NOTICE TO WITHHOLD INCOME FOR CHILD SUPPORT. Any income withheld from *AUBREY ROSHON TAYLOR*'s disposable earnings for child support and paid according to this order shall be credited against his child support obligation, but shall not discharge any of his child support obligation that exceeds the amount so credited.

It is FOUND *AUBREY ROSHON TAYLOR* is liable for all court ordered child support, regardless of the amounts withheld by any employer or entity, and *AUBREY ROSHON TAYLOR* is ordered to pay any court ordered child support not withheld by any employer or entity directly to the Texas Child Support Disbursement Unit as ordered.

In addition, any employer of *AUBREY ROSHON TAYLOR*, current or subsequent, is ORDERED to withhold income from the disposable earnings of *AUBREY ROSHON TAYLOR* for the payment of court ordered attorney's fees.

The Clerk of the Court, upon request, is ORDERED to cause a certified copy of the ORDER/NOTICE TO WITHHOLD INCOME FOR CHILD SUPPORT, with a copy of Texas Family Code Chapter 158 attached, to be delivered to *AUBREY ROSHON TAYLOR*'s employer.

*AUBREY ROSHON TAYLOR* is ORDERED to provide any subsequent employer with a copy of the ORDER/NOTICE TO WITHHOLD INCOME FOR CHILD SUPPORT.

### STATUTORY WARNINGS

**FAILURE TO OBEY A COURT ORDER FOR CHILD SUPPORT OR FOR POSSESSION OF OR ACCESS TO A CHILD MAY RESULT IN FURTHER LITIGATION TO ENFORCE THE ORDER, INCLUDING CONTEMPT OF COURT. A FINDING OF CONTEMPT MAY BE PUNISHED BY CONFINEMENT IN JAIL FOR UP TO SIX MONTHS, A FINE OF UP TO \$500 FOR EACH VIOLATION, AND A MONEY JUDGMENT FOR PAYMENT OF ATTORNEY'S FEES AND COURT COSTS.**

**TERMS AND CONDITIONS OF COMMUNITY SUPERVISION  
FOR NONPAYMENT OF CHILD SUPPORT**

The Court suspends the commitment and orders that *AUBREY ROSHON TAYLOR*, Respondent, is placed on community supervision through the HARRIS COUNTY DOMESTIC RELATIONS OFFICE ("DRO"). The term of community supervision is 120 months from the date of this order OR until all child support arrearages are paid, whichever occurs first, as determined by the Community Supervision. As conditions of community supervision, Respondent is ORDER to:

1. Pay current child support and medical support as order;
2. Pay the child support arrearage as ordered;
3. Pay court cost and attorney's fee as ordered;
4. Deliver to any employer a copy of the income withholding order within five (5) days of employment;
5. Report to the Community Supervision Officer at the Harris County Domestic Relations Office, 1310 Prairie, Suite 600, Houston, Texas 77002 (713) 755-5210: immediately on conclusion of the Court's hearing AND at lease once each month thereafter; OR at least once each week thereafter if not employed full-timed;
6. Report all changes in Job status, including employer's name, employer's address, home address, and home telephone number to the Community Supervision Officer AND the custodial conservator, within seven (7) days of any change;
7. Permit the Community Supervision Officer to visit the Respondent's home, job/work, or elsewhere, and to contact employers as necessary for the enforcement of this Order;
8. Participate in employment assistance service as offered by the Texas Workforce commission or any employment related services as directed by the Community Supervision Officer;
9. Complete referrals or counseling in the following areas as ordered by the Court or directed by the Community Supervision Officer:
