2. **AUBREY TAYLOR, INDIVIDUALLY AND DBA AUBREY R. TAYLOR COMMUNICATIONS, DBA HOUSTON BUSINESS CONNECTIONS NEWSPAPER AND DBA YOUR THOUGHT MATTERS NEWSPAPER** is liable to the Plaintiff, LEON HUBBARD for actual damages of \$ 9,500.00.
3. **AUBREY TAYLOR, INDIVIDUALLY AND DBA AUBREY R. TAYLOR COMMUNICATIONS, DBA HOUSTON BUSINESS CONNECTIONS NEWSPAPER AND DBA YOUR THOUGHT MATTERS NEWSPAPER** is further liable for reasonable and necessary attorney's fees in the amount of, \$4,750.00.
4. **AUBREY TAYLOR, INDIVIDUALLY AND DBA AUBREY R. TAYLOR COMMUNICATIONS, DBA HOUSTON BUSINESS CONNECTIONS NEWSPAPER AND DBA YOUR THOUGHT MATTERS NEWSPAPER** is further liable for prejudgment interest on the amounts awarded at the rate of ~~six~~ ^{five} percent ~~(6%)~~ ^{5%} per annum from May 9, 2012 to the date of this Default Judgment.
5. All costs of court incurred by the Plaintiff in obtaining this Default Judgment are taxed against **AUBREY TAYLOR, INDIVIDUALLY AND DBA AUBREY R. TAYLOR COMMUNICATIONS, DBA HOUSTON BUSINESS CONNECTIONS NEWSPAPER AND DBA YOUR THOUGHT MATTERS NEWSPAPER.**
6. Post judgment interest on all amounts awarded in this Default Judgment shall accrue at the rate of five percent (5%) per annum.

Upon this Default Judgment becoming a final judgment, the Plaintiff shall be entitled to all abstracts, writs, turnover relief, and all other legal and equitable relief in enforcing this Default Judgment against **AUBREY TAYLOR, INDIVIDUALLY AND DBA AUBREY R.
